

# **YOLA Nomination / Show of Interest Form and Instructions**

## **General**

To nominate someone for elected office or to volunteer for a committee position you must be a member in good standing. This means that you have no late dues, outstanding fees or fines, or Association liens against your property. These requirements also apply to anyone you nominate for an office.

Only the "Designated Representative" may make a nomination on properties owned by companies or with multiple ownership.

Please be sure to fill out each section completely. The Election Committee may cut these forms along the dotted lines and incomplete sections of the form will be discarded.

## **Elected Office Instructions**

Use one form for each Elected Officer you would like to nominate.

Clearly print the name of the Association member you would like to nominate on the line labeled "Name of nominee". Place a check in the box next to the position you would like to nominate them for. Print your name where it says "Name of nominator" and enter your tract # where indicated. Sign your name on the line labeled "Signature of nominator".

The Board will contact each person who receives two nominations to verify their willingness to run for the office they have been nominated for.

## **Committee Instructions**

Place a check in the box next to each Committee Chairmanship or Committee Membership that you are interested in. Print your name where it says "Name" and enter your tract # where indicated. Sign your name on the line labeled "Signature".
